**PUBLIC COMMENTS ON AGENDA AND NON-AGENDA ITEMS**

**Lynn Boone**, Compton resident, spoke in reference to the city's agreement with the Crystal Casino and the gaming revenue received for the month of December. Ms. Boone questioned the information provided by the Executive Secretary and encouraged the citizens to stay abreast of the Commission's activities.

**Joyce Kelly**, Compton resident, commented on the statements made by the Executive Secretary during last week's Commission meeting. Ms. Kelly stated that the approval of a bingo license at the Crystal Casino would result in a monopoly over the local organizations hosting bingo at their locations. Ms. Kelly asked that the Commission investigate the organization applying for the bingo license, citing concerns of fraudulent activity.

**William Kemp**, Compton resident, informed the Commission that a flyer is circulating throughout the community, announcing bingo gaming at the Crystal Casino on February 1, 2010. Mr. Kemp stated that this type of communication to the community, prior to the public hearing, implies a memorandum of understanding. Mr. Kemp indicated that someone may have instituted a memorandum of understanding with this organization prior to the public hearing, therefore he asked that an investigation be conducted.

**Chairperson Perrodin** asked the Executive Secretary if the Crystal Casino was required to give the city \$20,000 each month.

**Charles Evans**, Executive Secretary, explained that the Crystal Casino is required to give the city \$20,000 for every \$898,000 generated in one month.
