## **WILMINGTON AVENUE SAFE STREETS PEDESTRIAN/BICYCLE PATH IMPROVEMENT PROJECT CIP# 15-01**

The City of Compton will be performing another Public Works street improvement project. The Wilmington Avenue Safe Streets Pedestrian/Bicycle Improvements is a pedestrian and bicycle safety improvement project aimed to improve pedestrian and bicycle safety for the communities adjacent to the Wilmington Avenue Transportation Corridor by developing safer pedestrian crossings and intersections, as well as installing bicycle lanes to improve bicycle visibility and safety, thereby reducing collisions. The proposed pedestrian and bicycle safety improvements include the following:

- **El Segundo Boulevard at Wilmington Avenue** – Installation of wider and colored crosswalks, high visibility crosswalk striping, countdown pedestrian signals and enhanced pedestrian lighting
- **131<sup>st</sup> Street at Wilmington Avenue** – Installation of wider crosswalks, high visibility crosswalk striping, countdown pedestrian signals and enhanced pedestrian lighting
- **133<sup>rd</sup> Street at Wilmington Avenue** – Installation of wider sidewalks, pedestrian actuated traffic warning system, Rectangular Rapid Fire Beacon LED warning light and sign, and embedded LED flashing beacons
- **Wilmington Avenue between 137<sup>th</sup> and 139<sup>th</sup> Streets** – Installation of sidewalks along the westerly side of Wilmington Avenue
- **Stockwell Street at Wilmington Avenue** – Installation of wider crosswalks, high visibility crosswalk striping, countdown pedestrian signals and enhanced pedestrian lighting
- **139<sup>th</sup> Street at Wilmington Avenue** – Installation of wider crosswalks, high visibility crosswalk striping, countdown pedestrian signals and enhanced pedestrian lighting
- **Wilmington Avenue between El Segundo Boulevard and Rosecrans Avenue** Installation of Class II bike lanes with advisory signage and installation of four (4) solar powered speed feedback signs for speed control and attainment
- **Rosecrans Avenue between Wilmington Avenue and the Compton Creek** Installation of Class II bike lanes with wayfinding signage to connect the Wilmington Avenue Class II bike lanes (s) and El Segundo Boulevard.

At its' July 26, 2016, City Council awarded a construction contract (\$1,219,750) to Sully-Miller Contracting Company to improve pedestrian and bicycle safety for communities adjacent to the Wilmington Avenue Transportation Corridor. At its' June 28, 2016, City Council awarded a construction management services agreement (\$176,680) to LAE Associates, Inc. to provide construction managing services for the project. For project management information, please contact LAE Associates, Inc. at 714-993-2840.

The construction portion of the project is funded utilizing California Active Transportation Program (ATP) Cycle I Grant funds. The construction management portion is funded with Transportation Development Act (TDA) funds.

Construction is scheduled to start in mid-November 2016 and completed in 70 working days per the contract.
