The City Council of the City of Compton, at its regular meeting on January 10, 2017, will hold a public hearing beginning at 5:45 p.m., or as soon thereafter as the matter may be heard to consider:

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COMPTON, CALIFORNIA AMENDING SECTION 9-24 OF ARTICLE II (REGULATIONS PERTAINING TO SPECIFIC BUSINESSES, PROFESSIONS AND TRADES) OF CHAPTER IX (GENERAL LICENSING) OF THE COMPTON MUNICIPAL CODE TO PROHIBIT COMMERCIAL MARIJUANA ACTIVITY AND MARIJUANA DELIVERIES AND TO ADOPT REASONABLE REGULATIONS FOR INDOOR MARIJUANA CULTIVATION AT PRIVATE RESIDENCES AND AMENDING CHAPTER XXX (ZONING) OF THE COMPTON MUNICIPAL CODE TO PROHIBIT COMMERCIAL MARIJUANA ACTIVITY, COMMERCIAL MARIJUANA USES, AND MARIJUANA CULTIVATION WITH LIMITED EXCEPTIONS, IN ALL ZONES IN THE CITY AND MAKING A FINDING OF EXEMPTION FROM CEQA UNDER SECTION 15061(B)(3) OF THE CEQA GUIDELINES

Recommendation: The City Council will consider adopting an ordinance regarding marijuana that does the following:

1. Amends Section 9-24 of Article II (Regulations Pertaining to Specific Businesses, Professions and Trades) of Chapter IX (General Licensing) of the Compton Municipal Code in its entirety to prohibit commercial marijuana activity (including cultivation, possession, manufacture, distribution, processing, storing, laboratory testing, labeling, transportation, distribution and sale of marijuana and marijuana products for commercial purposes), to prohibit marijuana deliveries to and from the City, and to adopt reasonable regulations pertaining to the indoor cultivation of up to six marijuana plants at private residences consistent with State law.
2. Amends Sections 30-7 (Residential Agricultural Zone), 30-8 (Low-Density Residential Zone), 30-9 (Medium-Density Residential Zone), 30-10 (High-Density Residential Zone), 30-12 (Limited Commercial Zone), 30-13 (Commercial Manufacturing Zone), 30-14 (Limited Manufacturing Zone), 30-15 (Heavy Manufacturing Zone), 30-16 (Buffer Zone), 30-18 (Planned Development Zone) and 30-19 (Specific Development Zone) of Chapter XXX (Zoning) of the Municipal Code to prohibit (1) all commercial marijuana uses, (2) all outdoor marijuana cultivation, and (3) allow the cultivation of up to six marijuana plants indoors consistent with the State law.
